Who? Every registered member 14 years and older is encouraged to attend.

Why? The purpose of the regional meetings is to provide the membership with a direct link to the board of directors so that members may have the opportunity to:

- Give input and reaction to proposed plans/policy matters being considered by the board of directors.
- Initiate and submit, to the board, proposals directed toward the fostering and improvement of Girl Scouting within the council.
- Identify external and internal trends for the board's use in formulating corporate goals.
- Perform such other duties as may be delegated by the board of directors, including electing delegates to the Annual Meeting.

GIRL SCOUTS OF LOUISIANA – PINES TO THE GULF CONFUSED ABOUT REGIONS, DELEGATES, AND ANNUAL MEETINGS?

Here are some WHO's, WHAT's, and WHY's to help answer your questions.

WHAT are Regional Meetings and WHY are they important?

Regions are geographic areas within the council jurisdiction established by the board of directors. Regions fulfill two major functions of the council's democratic process.

- 1. Provide the structure for the election of delegates, formation of the corporation, and a formal channel of communication from the board of directors to the membership.
- 2. Allow the membership a way to participate in council business, enabling them to influence board decisions and the council's strategic plan, react to and give input on matters that may be referred by the board of directors, and initiate proposals to the board of directors on matters of importance to the total membership.

WHY are delegates elected and WHAT do they do?

In Girl Scouts of Louisiana – Pines to the Gulf, delegates are elected through regional meetings to be members of the corporation (or to be the delegate body).

Delegates must attend the Annual Meeting where they have an opportunity to fulfill the following responsibilities:

- 1. Give direction for Girl Scouting within the council's geographic area.
- 2. Receive the stewardship report from the board of directors, including a report on the council's financial status.
- 3. Hear any other pertinent reports.
- 4. Take part in discussions about major areas of concern or future actions that will have an impact on the total council.
- 5. Take action on proposals that have been approved by the board of directors.
- 6. Amend the council articles of incorporation and bylaws.
- 7. Elect the officers and members of the board of directors and nominating committee and the delegates to the National Council.

Delegates need to be informed of the issues to be discussed at the Annual Meeting before the meeting day. The council will provide training and/or an informational packet to meet this need of the delegates.

THE DELEGATES HAVE THE AUTHORITY BOTH TO GIVE GUIDANCE TO THE OVERALL POLICY DIRECTION OF THE COUNCIL AND TO ELECT THOSE RESPONSIBLE FOR ONGOING POLICY DECISIONS – THE CORPORATE OFFICERS AND BOARD MEMBERS.

As delegates participate in the official business of the corporation (council), they become members of the select group of individuals who are fulfilling our founder, Juliette Low's dream that the representatives from every community be involved in making decisions about the future of the Girl Scout movement in the United States of America.

WHY are Annual Meetings important?

The Annual Meeting is a Girl Scout council's deliberative assembly – the factual reality of its democratic principles and practices. It is important for several reasons.

- 1. The corporation (council) is required by state law to meet at least once a year.
- 2. The annual meeting provides the opportunity for delegates to become involved in the council's planning process and be informed on the anticipated future of Girl Scouting in the council.
- 3. The business conducted by the council at the annual meeting the election of its volunteer leadership and discussion of major policy issues legally enables the corporation (council) to continue its work.

WHO may attend the Annual Meeting?

- 1. It is the responsibility of the elected delegates to attend the meeting.
- 2. Any registered Girl Scout 14 years or older is also invited to attend.

Note: Only elected delegates have the power to vote.

The Outdoor Pillar

From the backyard to the backcountry, Girl Scouts has a long and storied history of getting *every* girl outdoors. In fact, many Girl Scouts tell us "camping trips" are one of the best things about their Girl Scout experience. It's true: connecting with the great outdoors in a girl-led setting is a big benefit of belonging to Girl Scouts.

Studies show that girls today are not spending nearly enough time outdoors. Technology and structured activities leave less time for girls to get outside and enjoy nature. But as a Girl Scouts, girls have opportunities to create their own outdoor adventures and develop a lifelong appreciation for nature and the out-of-doors—whether with her troop, at camp, or with friends and family.

And that's great news—because when Girl Scouts get outside, they:

- Discover that they can better solve problems and overcome challenges
- Develop leadership skills, build social bonds, and are happier overall
- Become team players and care more about protecting our environment

When girls spend quality time outdoors and increase their exposure to nature, they thrive physically, emotionally, and intellectually. For these critical reasons, we plan to encourage every Girl Scout to take advantage of the excellent outdoor experiences provided at our two council camp properties, Bon Temps, and Wawbansee.

Approximately 12% of GSLPG's Membership visited the camps during the 2019 Membership Year. **Consequently, 88% are missing out on valuable outdoor learning experiences.**

With this in mind, we look forward to utilizing our time together at the 2019 Regional Meetings discussing and brainstorming solutions that will provide more girls these experiences. At the same time, we also hope to impact camp utilization positively. And, while we've made much progress with improvements and maintenance, there is still more to do, and the properties must continue to be well maintained.

Additionally, revenue from the camp properties is minimal compared to the hefty expenses that continue to grow. Consequently, we must contemplate strategies to increase income that can support quality experiences adequately.

Look at how the cost of our shopping baskets changed over time


Check this out. Seeing as camp user fees have not increased since 2004, we thought it would be helpful to get a picture of how the cost of goods and services have changed over time. See the Price Basket below.

What's included? The basket is representative of the goods and services that most of us purchase weekly. It was created to show the effect that inflation has on typical weekly spending. The data was collected between 2008 to 2014 and includes a mix of 30 + items including food, goods and services. One of the many things it shows is inflation as measured by basic food and just 1 gallon. While this data is unscientific, a vast amount research was collected from original sources like local newspapers, history textbooks, old catalogs, and magazines. It provides an excellent picture of the impacts of inflation over the years.

ACTION PROPOSALS: PUTTING IDEAS INTO ACTION

The following material is intended to assist the membership in formulating proposals and use of channels so that <u>communication</u> between members, the board of directors, and the chief executive officer may effectively occur.

There are several channels that are open to the membership. Communicate idea while it is in the early conception state to:

Region Convener
Service Unit Manager
Troop Support Specialist
Chair of the Council
Chief Executive Officer
or
Mail to Council Service Center

It will be processed and sent to the proper group or person for an answer and/or implementation. Proposals concerning Council Policy should be directed to the board of directors and proposals concerning operations should be directed to the chief executive officer.

The individual or group initiating the idea should formalize the idea and submit a written proposal containing:

- 1. A statement of the action desired.
- 2. The reason for the action and the anticipated results.
- 3. Suggestions for carrying out action.
- 4. The support or the number of people supporting the proposals.

Persons initiating proposals will receive prompt replies to their proposals. Assistance is available from the Region Convener or the membership specialist to an individual or group in formalizing the proposal.

If the proposal involves action at the council meeting, it is advisable to plan a three-month time period between the origin of the proposal and council meeting.
