

Juliette Program Fund Guidelines

Girl Scouts of Louisiana – Pines to the Gulf (GSLPG) encourages all girls that are registered as Independently Registered Members to participate in the Cookie and Fall Product Programs. Proceeds earned through participation in these sales will be placed in a Service Unit Juliette Program Fund to be used to support program opportunities for all registered within that service unit that have participate in the programs.

In order to receive support from the Juliette Program Fund girls must be currently registered as a member and have participated in the Cookie and Fall Product Programs as a Independently Registered Member.

Funding request may not exceed the actual amount earned through Cookie and Fall Product Programs. Disbursements from this fund will be based on history of participation in Cookie and Fall Product Programs, available funds for disbursement and the program benefit for girls.

Approved request for funding:

Membership - \$25 annually, transmitted through GSLPG to Girl Scouts of the USA

GSUSA encourages girls to designate a portion of their group treasury for the annual membership dues of its members. This is a sound and efficient practice that enables girls to meet membership dues and lessens the potential burden to individual members. Therefore requesting membership dues from the Juliette Program Fund is supported and encouraged. The timing of the Cookie Sale Program makes funds available for early re-registering in the spring.

Events - Council Sponsored and Approved Service Unit

Events held at the Service Unit level are excellent opportunities for IRM's to participate in program opportunities with other Girl Scouts

Attach a copy of the event flyer to the Juliette Program Fund Application. Payments will be sent directly to the event coordinator at the Service Unit. We recommend that you connect with the event coordinator so they hold a space for you while the payment is in process.

Destinations

Once a girl is accepted to participate in a destination she may request funding from the Juliette Program Fund. After acceptance into the destination is confirmed by the program department with the hosting council, payment will be send directly to the council or organization hosting the desintation.

Camp

Summer Camp is an opportunity for IRM's to participate in outdoor activities in a group environment. GSLPG lists camp opportunities online at www.gslpg.org and a summer camp brochure is mailed to every registered Girl Scout a few months prior to the camp season.

When registering for summer camp we recommend you complete the registration form and turn it in to the appropriate camp director indicating that Juliette Funds have been requested. Submit the Juliette Program Fund Application along with a copy of the Camp Registration Form to the council for approval and fee disbursement to the camp.

Council Shop

The Juliettes Program Fund is available for purchases in the council shops. Girl may purchase uniforms, books and badges that they have earned.

Prior to visiting the shop, submit your request and indicate how much you might want to spend. Once approved, the form will be sent to the IRM and a copy forwarded to the retail shop. The girl can then proceed with her purchases.
