Why the change?

To support volunteers and council staff by streamlining the Activity Accident insurance process.

What are the benefits?

- Eliminates administrative burden.
 - Reduces complicated decision making.
- Provides expanded coverage.
 - Saves on overall cost to the Movement.

Activity Accident

Basic Plan 1

Automatic Coverage *Expanded*

Basic Plan 1

will *automatically* include:

- ✓ Non-member participants (invited attendees)
- ✓ ALL trips (including > 2 overnights)
 - ✓ Tagalongs (siblings /children)
- ✓ Younger children in Girl Scout supervised units

Plan 2 is eliminated!

Volunteers and staff will no longer need to individually purchase coverage for all the above!



Plan 1

Activity Accident — The basic plan covers accidents for Members and Nonmembers for any approved, supervised Girl Scout Activity.

Plan 3P

Activity plus Sickness — Plan 3P covers accidents plus sickness for Members and Nonmembers for any approved, supervised Girl Scout activity.

Plan 3PI

Activity plus Sickness for International Trips - Plan 3PI covers accidents plus sickness for Members and Nonmembers for any approved, supervised international Girl Scout activity.

International Inbound

Activity plus Sickness for Inound International Trips: This plan covers accidents plus sickness for Members and Nonmembers that are traveling to the United States internationally.

NCS Proposal 1	Constitutional Amendment: Allowing the Possibility of Virtual Attendance for National Council Sessions and Special Sessions of The National Council	Approved As Amended
NCS Proposal 2	Constitutional Amendment: Amend the Girl Scout Promise and Law to use more potent, actionable language; THAT the Preamble of the Constitution of the Girl Scouts of the United States of America be amended to delete the words "try," and "do my best" and to insert the word "will."	Defeated
NCS Proposal 3	Constitutional Amendment: Council Representation on the National Board; To amend Article X, Section 2 of the Constitution of Girl Scouts of the USA to insert "at least three (3) of whom shall be Council Executives." After the words "members-at-large," and to insert the definition of "Council Executive" after the word "country."	Defeated
NCS Proposal 4	Constitutional Amendment: DEIRJ Language Proposal ; Girl Scouts advance diversity, pluralism, and anti-racism and actively identity and oppose racism by removing systemic barriers to participation in our Movement and in the communities in which we live.	Approved as Amended

NCS Proposal 5	Constitutional Amendment: Formula for Delegates ; To amend Article IV, National Council, Section, 5 by striking the number 2,500 in every place where it occurs and replacing it with the number 1,000 and by striking the word "no" and replacing it with the words "as close to but not" in the last sentence.	Defeated
NCS Proposal 6	Constitutional Amendment: That Article IV (The National Council), Section 5 (Formula for Delegates) of the Constitution of Girl Scout of the USA be amended by striking "of the Year," and inserting the words, "two years" before the word "preceding."	Approved as Presented
NCS Proposal 7	Girl Scout Gold Award Scholarship: That the National Council hereby affirms the recommendation of the Movement Gold Award Scholarship Foundation Task Force to create a donor-restricted fund in support of Gold Award scholarships; and that in recognition of its importance, the existence of such fund shall be reflected in the Blue Book of Basic Documents in the Fundraising Policies section of the Blue Book (or any successor section of the Blue Book as may be appropriate from time to time).	Approved as Presented




